The Official Military Personnel File (OMPF) needed to answer your inquiry is not in our files. If the OMPF were here on July 12, 1973, it would have been in the area that suffered the most damage in the fire on that date and may have been destroyed. The fire destroyed the major portion of records of Army military personnel for the period 1912 through 1959, and records of Air Force personnel with surnames Hubbard through Z for the period 1947 through 1963.

An alternate record that is available for the veteran named in your request is a *Final Pay Voucher*. This particular document is an archival document belonging to the National Archives and is available to you for a fee. To help you decide if you would like to purchase the final pay voucher pertaining to the veteran named in your request, we are enclosing information about the document and a sample copy of an actual final pay voucher.

If you are interested in purchasing the final pay voucher, please complete the attached '*Order for Archival Record Reproduction Services*' form. Please return this form with your payment within 30 days. Once payment is received, a photocopy of the final pay voucher will be mailed to you. 
